Morphology (which is the study of word formation and word structure) and syntax (which is the study of the structure of utterances or grammatical patterns) are two essential systems here. Hence, words are used in sentences according to their forms/classes, and the functions particular

words perform in sentences determine their designation as a particular class of word. This is the idea of the term "part of speech", which is synonymous with the term "classes of words".

This paper holds significance not only for the specific academic community but also for the broader educational landscape. This research underscores the importance of innovative instructional methods in language education. Odehova et al. (2022) presented the results of the experimental enquiry aimed at studying the impact of cooperative learning on improving grammar skills. The research focused on two interaction modes – pair work and group work, which were compared in terms of their potential to address accuracy. The presented evidence suggests that grammar instruction can clearly benefit from incorporating both pair work and group work into classroom practices. Sujana et al. (2020), integrated the deductive method and holistic assessment approach, the integration produced a significant improvement in the TOEFL test (SWE section), with an increase of 63.24 points – from an average 388.84 on the pre-test to 452.01 on the post-test; (3) students responded positively to both the model used and the implementation of the deductive method and holistic assessment resulting in a significant improvement in TOEFL scores.

According to Huang et al. (2020), study of the effectiveness of using Grammarly in EFL writing revealed that students' writing performance significantly increased throughout the 16-week intervention and the students were satisfied with the AI-based writing evaluation program as determined through written feedback. This suggests that applying Grammarly in writing classes is an effective approach for EFL students in developing writing skills and help teachers reduce teaching load. So Grammarly can help students improve their writing skills and help

teachers reduce their workload. Wang et al. (2018) demonstrated the efficacy of the jigsaw technique, a form of cooperative learning, in improving students' understanding of grammar. This study highlights the importance of collaborative approaches in language education and suggests that cooperative learning strategies can enhance grammar comprehension among students. The research study investigates the effects of jigsaw cooperative learning (JCL) on academic motivation (AM), academic hardiness (AH), and self-efficacy (SE) of English as a Foreign Language (EFL) learners. JCL is an educational strategy that emphasizes collaboration, interdependence, and group cooperation. However, limited research has examined the specific impact of JCL on these factors among EFL learners; results suggest that the application of JCL techniques can facilitate the development of AM, AH, and SE among EFL learners. These findings have implications for EFL instructors and practitioners, as they can utilize JCL strategies to enhance their learners' AM, AH, and SE in the classroom. From the above studies, I found out that a lot of work have been done on improving academic performance in English language but have not paid adequate attention to enhancing the academic performance in English language through Jolly Grammar Methods.
